Judicial hearing carried out at Donington Park 28/08/2025 due to time constraints at Croft.

Car 59 did not slow sufficently under double yellow signals. Car 59 and 2 other cars were travelling in close proximity and as a result i have mitigated the penalty for the offence.

Driver and team manager of car 59 interviewed. In car footage from cars 59, 62 & 95 viewed.

This decision was given verbally and in writing and drivers were advised of their right of appeal. Any appeal will be brought before the Stewards at Donington Park 30/08/2025.
