Following investigations I find that you are guilty of contravening Motorsport UK **NCR Ch.2, App.1, Art. 1.14** namely **Ch.12, App.8, Art.1.7**:

(f) Double Flashing/Waved Yellow - overtaking or not slowing down between signal and incident (Ch.12,App.8,Art.1.10)

Additional Information / Reasons for Decision:

Judicial hearing carried out at Donington Park 28/08/2025 due to time constraints at Croft.

Car 95 did not slow sufficiently under double yellow signals. Car 95 and 2 other cars were travelling in close proximity and as a result i have mitigated the penalty for the offence.

Driver and team manager of car 95 interviewed. In car footage from cars 59, 62 & 95 viewed.

This decision was given verbally and in writing and drivers were advised of their right of appeal. Any appeal will be brought before the Stewards at Donington Park 30/08/2025.
