The Stewards heard evidence from the following persons:

the driver and entrant of car# 38. Screenshots from the track limit cameras at turn 4 and turn 9 were also viewed.

The Stewards decision is:

the Appeal is successful and the decision of the Clerk of the Course is varied per NCR 5.4.2.17h. The Stewards find that there was a breach of track limits by driver #38 under NCR 12.7.1.6 and impose a fresh penalty of a drive through (converted to 30 seconds in addition to their elapsed race time).

Reason(s) for this decision:

The Stewards find that it cannot be determined in this instance that by breaching track limits the driver of car #38 gained an advantage.

However, the Stewards find that the driver of car #38 did breach track limits in violation of NCR 12.7.1.6 on over five occasions.

The Stewards note that NCR 12.7.1.11 is, firstly, advisory in nature as it states breaches of NCR 12.7.1.6 "may" be penalised in the scale it sets out, and secondly, it is only stated that "care should be taken to ensure that all Signals (flag and / or Light Board / Panel) should have been displayed to the Driver concerned before moving up the penalty scale". This is not a mandatory requirement in the view of the Stewards.

As the driver of car #38 breached track limits on over five occasions the Stewards find that the appropriate penalty is a drive through. As this drive through penalty was imposed after the race this is converted to an addition of 30 seconds to the vehicle's elapsed race time.
