Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

**Ch.12, App. 7, Art. 1.8** – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Following a report of contact between Cars 10 and 40 at Turn 9 Lap 12 and review on-board footage from both cars and interviews with both drivers and Team Managers I find that car 10 was predominantly to blame for causing the contact and subsequent spin of Car 94.

Accordingly under Motorsport UK Regulation **NCR Ch.5, Pt A, App 5, Art 2.3 (c)**, I order that you:
