Report of Car 70 impeding Car 43 during the qualifying session.

The Drivers of Cars 43 & 70 interviewed with their Team Managers. On-board footage reviewed.

Car 43 was on a qualification lap whilst Car 70 was on a slow lap/warming tyres. Car 70 was on the racing line and braked between Turn 6 & 7. Car 43 had to change their line to avoid the slow moving car 70. Both cars remained on the track.

The drivers briefing contained specific reference to not impeding or blocking other cars during Qualifying.
