Following investigations I find that you are guilty of contravening the following Motorsport UK

NCR: Ch.12, App. 7, Art. 1.5 (f) - Carrying out manoeuvres liable to hinder another driver, crowding a car beyond the edge of the track

Additional Information / Reasons for Decision / Evidence Used:

Marshal report from Post 9 of Car 3 'pushing' Car 7 in to the gravel trap at Turn 8 (Taylors Hairpin).

Interviewed the drivers of Car 3 & Car 7 with their Team Managers. Viewed on-board from Car 3, Car 7 and Car 56 which was directly behind this incident.

Car 3 initially made a pass on Car 7 at the entry to the hairpin. Car 3 was in front at the apex, then on the exit of the hairpin continued to move to the left making contact with Car 7 which was on the left hand side of the track.

Car 3 is considered to have crowded car Car 7 beyond the edge of the track.
