Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

Ch.12, App. 7, Art. 1.8 – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Side to side contact reported between Car 44 and Car 5, both cars continued.

Interviewed the drivers of Car 5 and 44 with their team managers. Reviewed on-board footage from Cars 5 and 44. Car 44 made side to side contact with Car 5 at Turn 1 as they passed for position. The driver of Car 44 stated that the contact was unintentional and this was accepted by the driver of Car 5.
