Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

Ch.12, App. 7, Art. 1.8 – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Marshal report of contact between Car 87 and Car 5 at Turn 8 Taylor's Hairpin.

Interviewed the driver of Car 5 with their team manager. The driver of Car 87 was represented by their team manager. On-board footage was reviewed from both car 5 & 87. Car 87 made nose into side contact with Car 5, no position change occurred with both cars continuing.

Car 87 was considered to have caused a collision.
