Following receipt of a **Non-Compliance Report** in compliance with **NCR Ch.2, App.8, Art.1.4 and Art.1.8** from a Scrutineer / Eligibility Scrutineer / Technical Commissioner, and after holding a hearing in accordance with **NCR Ch.2, App.8, Art.1.9** where you were given the opportunity to provide mitigation, I find that you are guilty of contravening regulation(s):

Championship Regulation 5.9.4 DIFFERENTIALS
Limited slip and Automatic Torque Biasing differentials are prohibited.

Additional Information / Reason(s) for Decision / Evidence

Protest received from car 95 Joshua Wilby (Team Avago).

Gearbox and Differential were inspected at the circuit and taken for further examination from a specialist as agreed by both parties. Before the inspection occurred Westbourne Motorsport (Car 38) sent a letter of admission confirming breach of CR5.9.4.

As a result, the status of the gearbox in Car 38 is reverted to the last sealed configuration prior to Round10. Subsequently car 38 is to be disqualified from the results of rounds 10, 11, 12 (Croft) and 13, 14, 15 (Donington Park GP) of the Championship.

The protest has been upheld and the fee is returned.
