NCR: **Ch.12, App. 7, Art. 1.5 (f)** – Carrying out manoeuvres liable to hinder another driver,
crowding a car beyond the edge of the track

Additional Information / Reasons for Decision / Evidence Used:

Car 25 on a slow lap moved back to the racing line whilst car 33 was on a qualifying lap, forcing car 33 of the circuit.
