Ch.12, App. 7, Art. 1.8 – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

On entry to turn one, the front wing of car 3 made contact with the rear left tyre of car 32.

Car 3 is held responsible as there was room on the left hand side for car 3 to use.
