The Stewards decision is:

The Appeal Fails and the decision of the Clerk of Course is upheld

Reason(s) for this decision:

The Stewards heard verbal evidence from all parties and viewed all video footage available. The Appeal was based on the wording of the F4 Driving Standards Guidelines and the Clerks reference to that document. The Stewards considered all the evidence presented and decided that the driver of Car #7 did meet the requirements of the Guidelines. Further, the Stewards heard that the Driver of Car #51 confirmed that he was aware of the presence of Car #7 attempting an overtake on the inside and whilst space was initially available this was a diminishing gap on track between Car #51 and the Apex of Turn 1, which resulted in contact between the two cars
