Additional Information / Reasons for Decision / Evidence:

Lap 1 Turn 4 incident with Car 99. Car 78 overtook at the apex of the corner and failed to leave room at the exit of the turn for Car 99, thus forcing Car 99 off the circuit and into the gravel.
 Onboard footage from both Cars Viewed along with ITV footage.
 Drivers and team managers present.
