Additional Information / Reasons for Decision / Evidence:

Marshal reports of contact between Cars 16 & 76 at Turn 9 on VBox Lap 12. Car 16 continued, Car 76 spun into the gravel and did not continue.

Reviewed on-board footage from Cars 16 & 76. Interviewed the driver of Car 76 with their team manager. Car 16 was represented by their team manager.

Car 16 is considered to have caused a collision.
