Additional Information / Reasons for Decision / Evidence:

Approaching turn 2, car 13 made contact with the right rear of car 88 forcing 88 into a spin.

On board footage from cars 88 and 24 (evidence car).

Driver and team manager from car 13 interviewed.

Team manager from car 88 interviewed, driver requested the night before to be available at 09:00 but not in the venue at 09:45.
