Additional Information / Reasons for Decision / Evidence:

Going round turn two, car 15 on the outside off car 2, car 15 met the F4 guidelines, car 2 lost control and made contact with car 15. Car 15 made contact with the barrier and retired.

On board from 2, 15 and 5 (evidence car) ITV footage all viewed.

Driver and team manager from both cars interviewed.
