Additional Information / Reasons for Decision / Evidence Used:

Going through turn 2, car 83 on the inside, car 27 on the outside, car 27 met the F4 guidelines. On the exit car 83 never left a cars width for car 27, forcing car 27 off the circuit.

On board footage from both cars viewed.

Driver and team manager from both cars interviewed.
