Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

Ch.12, App. 7, Art. 1.8 – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

First lap of the race, exiting turn one, car 15 moved from the left to the right hand side of the track making contact with car 51, 51 lost a number of places because of the contact having gone onto the grass.

On board footage from cars 15 and 51 viewed, ITV footage viewed.

Driver and team manager from both cars interviewed.
