Additional Information / Reasons for Decision / Evidence Used:

Exiting turn 3 car 27 gets an overlap on car 22, car 22 moves to the left forcing car 27 onto the grass, car 27 lost one place.

On board footage and ITV footage viewed.

Driver and team manager from both cars interviewed.
