Ch.12, App. 7, Art. 1.8 – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Car 9 made a overtaking move at turn 3, on the inside, on exiting the corner contact was made between the right front wheel of car 9 and left side pod of car 1, forcing car 12 to spin .

On board footage from cars 9 and 12 viewed, ITV footage viewed.

Driver and team manager from both cars interviewed.
