Additional Information / Reasons for Decision / Evidence:

Entering turn two car 2 goes past car 15 on the left, car 53 goes past car 15 on the right, contact was then made between the front left of car 53 and rear right of car 2 causing car 2 to spin.

On board footage from cars 2, 15 and 53 viewed.

Driver and team manager from cars 2 and 15.

Team manager from 53 interviewed.
