### Additional Information / Reasons for Decision / Evidence:

Entering turn 6, car 88 attempted to overtake car 4 on the inside, contact was made between the front left of car 88 and the rear right of car 4, which caused car 4 to spin into the gravel trap and retire.

On board footage from cars 4 and 88 viewed.

Team manager from cars 4 and 88 interviewed, drivers not present.
