Additional Information / Reasons for Decision / Evidence:

Car 2 overtaking car 21 on the inside of turn 1, meeting the F4 guideline, car 2 lost control at the apex and made contact with car 21. Car 21 retired from the race.

On board footage from both cars and ITV viewed.

Driver and team manager from both cars interviewed.
