Additional Information / Reasons for Decision / Evidence:

Coming down the Bentley Straight, car 53 following car 22, car 53 moves to the left and car 22 then moved to the left to defend, which is against F4 driving standards, contact was made between the front of 53 and rear of 22. both continued.

On board footage from both cars and ITV viewed.

Driver and team manager from both cars interviewed.
