Additional Information / Reasons for Decision / Evidence:

On entering turn 2, car 44 moved up the inside of car 9, didn't meet the F4 guidelines, making contact with car 9 who then made contact with car 12. Cars 9 and 12 retired.

On board footage from cars 9, 12 and 44 viewed.

Driver and team manager from cars 12 and 44.  
Manager from car 9, driver not present.
