Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

Ch.12, App. 7, Art. 1.8 – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Report of contact between Car 44 and Car 16 at Turn 2 (entry to Druids Hairpin). Both cars initially stopped and then continued. Reviewed on-board footage from Cars 44 and 16. Car 44 made nose into side contact with Car 16. Interviewed both drivers. Car 44 is considered to have caused a collision.
