Additional Information / Reasons for Decision / Evidence:

Contact between Car 84 and Car 4 on Lap 1 - Turn 1.
 Reviewed onboard footage from Cars 84, 4 and 20 which was behind this incident
 Interviewed the drivers of Car 84 & 4.
 Cars 84 was considered to have not left sufficient space for Car 4 which was alongside resulting in a collision.
