1.3 **PASSES:**

For those without permanent passes, electronic tickets will be sent to you; those under the age of 13 are admitted free of charge. Under no circumstances will any private cars, including marshals' cars, be permitted into the paddock at any time during the event.

1.4 **SIGNING-ON:**

All Officials will sign-on for the event electronically using the [BARC Alpha System](#). Raceday programmes will be produced for the Event and additionally entry lists will be available on the BARC website.

1.5 **ENGINE/NOISE POLLUTION:**

Engines must not be run before 08:30 or after 18:45 on both days and noise checks will take place at the entrance to the assembly area for all support race categories.

1.6 **CIRCUIT ACCESS: PRACTICE AND QUALIFYING PROCEDURE**

All competitors should follow the instructions within their Championship Regulations and any championship bulletins issued for this event.

1.7 **LIVE SNATCH:**

There is no "live snatch" at this event, however the Clerk of the Course may use vehicles to move stranded race cars while the safety car is in operation.

1.8 **RED SIGNAL:**

Any category which generates a "red" may be placed toward the end of the schedule subject to time being available.

1.9 **JUDICIAL PROCEDURES:**

The judicial procedures for this event will be as described in the Motorsport UK NCR with all paperwork being dealt with electronically. Any protest or appeal needs to be lodged with the Event Secretary in the administration office or with the Championship Clerk of the Course.

1.10 **RESULTS & NOTICE BOARD:**

All time sheets, grids and results are deemed to be provisional until the conclusion of all judicial actions.

1.11 **CIRCUIT & EVENT NOTES:**

BARC will not be liable for any damage caused to vehicles being recovered from the track.

1.12 **SOCIAL MEDIA**

Both officials and competitors are reminded that they should not make comments upon social media sites which may in any way be deemed derogatory, defamatory, obscene, or libellous. You should remember that comments made are in a public arena and can be seen by more than your intended audience.

1.13 **SAFEGUARDING:**

A number of officials within the club are appointed as safeguarding officers and are available to deal with problems which may arise or are brought to their attention. Issues can be raised by contacting the senior clerk of the course at the event or contacting a club safeguarding officer whose details can be found on the BARC website.

1.14 **MARSHALS MATTERS:**

- a) The Marshals Campsite will be behind and beyond the Timekeepers building along the outside of Senna Straight. To reach this area turn left immediately after entering the main gate and follow the perimeter road as far as you can go, (this is mainly a hard-core surface so take your time, especially if you are towing a caravan).
- b) Do not park on the concrete apron immediately behind the Timekeepers building as this area will be required by the Television Company. Additional water points and toilets will be supplied by the circuit, please treat them with respect. Initial parking for marshals in cars only will also be in this area. After checking in with the chief marshal you will be allowed to drive to certain posts. No marshals' private cars will be permitted in the paddock at any time.
- c) Please obey the venue speed limit (20 mph) and any directions given by the circuit staff. Due to the layout of the circuit, access to certain areas is very restricted. There will be maps of the circuit and marshals post allocations available at check-in.

Special Notes:

- a) You are reminded that Light Signals are installed at Snetterton and they must be the priority signal used at all marshals posts rather than flags. It is imperative that the circuit light panels are operated quickly to signal to competitors as this will also trigger the in-car display to each driver. There will be set of flags on each post and these should only be used in the case of a system failure or to supplement the light signals by displaying additional signals of lesser importance than that displayed on the light panel. Signals for the Safety Car and for Stopping a session will be initiated and controlled by Race Control.
- b) Scrutineering will be in accordance with Motorsport UK NCR 12.4.4 which means that a minimum of 25% of the competitors in each championship will be selected for full physical scrutineering and all competitors will also completing a self-declaration form.

No mini-bikes, scooters or 2-wheeled transport allowed. Observe venue speed limit at all times. Absolutely NO electric stand-on scooters.
