### Additional Information / Reason(s) for Decision / Evidence

It is clear via the Race Tyre control app which is the MINI CHALLENGE official tyre nomination app that the driver of car 94's tyres were not registered prior to the start of the practice/qualifying session.

The qualifying session started at 12:09:10 and the evidence via the app shows the tyres being nominated at 12:43 & 12:31.

Be disqualified from the results of **Qualifying Practice** **Ch.2, App.8, Art.1.10**

And,

- Be penalised under **NCR Ch.2, App.8, Art.2.2 (a) & (b) - Mandatory**
- Be penalised under **NCR Ch.2, App.8, Art.2.2 (c) (Loss of two first place points scores) Refer to Championship Regulations**
- Be charged a fee in respect of costs in the sum of: **(Ch.2, App.9, Art.2.11 and Ch.3, App.11, Art.1.11 k)**

No penalty points are recorded on your licence as a result of above
