Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

Ch.12, App. 7, Art. 1.8 – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Car 10 made front to rear contact with car 70 causing car 70 to lose control and several places in the race.

Onboard footage of car 10, 70 and evidence car viewed and verbal evidence was submitted by both drivers and team managers. Team Managers (entrants) were Jamie Going (Jam Sport) and Neil Greenland (ProAlloys).

As per championship regulation 4.2.2 (ii, car 10 is to receive an a 2 place grid penalty in the next available race.
