Additional Information / Reasons for Decision / Evidence:

Car 24 made a significant direction change in the braking zone of Wilson causing car 111 to lose control and leave the circuit
Onboard footage of car 24, 111 & evidence car viewed and verbal evidence was submitted by both drivers and team managers.
