Following investigations I find that you are guilty of contravening the following Motorsport UK

NCR: **Ch.12, App. 7, Art. 1.5 (f)** – Carrying out manoeuvres liable to hinder another driver, namely crowding a car beyond the edge of the track

Additional Information / Reasons for Decision / Evidence Used:

An Incident between Car 48 and 78 on the exit of Clearways resulted in contact and Car 78 being forced off the circuit. Car 78 was far enough alongside at the exit of the corner to be afforded track room.

Onboard footage from Cars 48 and 78 Viewed and Drivers and Team Managers interviewed.
