Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

Ch.12, App. 7, Art. 1.8 – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Car 33 made contact with car 12 at Island causing car 12 to lose a position in the race. It was noted that car 33 moved to the right side of the circuit, slowed and gave the position back.

Onboard footage of car 33 & 12 viewed and verbal evidence was submitted by both drivers and team managers.
