Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

**Ch.12, App. 7, Art. 1.8** – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

### Additional Information / Reasons for Decision / Evidence:

Contact between Car 92 and Car 56 on the entry to Turn 1 (Old Hall). Both cars continued.  
 Drivers of Car 93 & 56 interviewed with their team managers. On-board footage reviewed from both cars.  
 Car 92 overtakes Car 56 on the inside. Car 56 stays left on the track at all times in the incident, Car 92 moves left and makes contact with Car 56.  
 Car 92 is considered to have caused a collision.
