Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

**Ch.12, App. 7, Art. 1.8** – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Reported contact between car 9 (Colin Atkinson) and car 15 (Elspeth Clark) at Druids corner. On reviewing the evidence from on board camera footage and driver's verbal explanations. Car 9 (Colin Atkinson) was predominately to blame for causing a collision during an overtaking manoeuvre on the inside of car 15. Car 9 lost control briefly during the overtake and understeered into car 15.
