Thomas Toovey, JHR Developments Team Manager - Lewis Wherrell, Competitor #10 was summoned however whilst aware that the Hearing was imminent he did not attend - All parties agreed under NCR 2.3.1.10 that the Hearing would proceed in his absence.

The Stewards decision is:

The Appeal fails and the decision of the Clerk of Course is supported.

Reason(s) for this decision:

The Stewards are aware that an incident at the end of Lap 1 at the Chicane involving several front running cars required awareness by following competitors. The Stewards are therefore comfortably satisfied that, having heard the evidence from all parties (both verbal and video), they consider that the driver of Car #7, Theo Palmer, did not take sufficient action to prevent a collision and therefore was predominantly responsible for the collision with the rear of Car #10.
