NCR: **Ch.12, App. 7, Art. 1.5 (f)** – Carrying out manoeuvres liable to hinder another driver, namely crowding a car beyond the edge of the track



Additional Information / Reasons for Decision / Evidence Used:

Car 722 moved alongside car 734, car 734 moved right and crowded car 722 to the edge of the circuit and minimised the space available.

Both drivers interviewed and on board footage from both cars viewed.
